

PRIZE MONEY RULES

Open and Beyond limits (people with disability)

1. ELIGIBILITY

Prize money is applicable only to Indian citizens who are officially registered participants of ACER RUN 2026, complete the full race, cross all timing checkpoints, have official start & finish times recorded by the timing system and comply with all Race Rules, Regulations, and directions issued by ACER RUN 2026.

2. PRIZE CATEGORIES

Open Category is open to all eligible Indian participants. Beyond Limits Category (Persons with Disabilities) participants must register under the designated category, produce a valid disability certificate upon request, meet all eligibility criteria as verified by the Official Timing Partner and comply with all rules.

3. PRIZE DETERMINATION

Prize positions will be determined based on Net Time. All Race Day results are provisional until verified by the Official Timing Partner, Sports Timing Solutions. The decision of Sports Timing Solutions regarding race timing and results shall be final and binding. Prize winners must submit required documents for verification. Verified prize money will be transferred within 14 working days after Race Day.

4. DISQUALIFICATION

Participants shall be disqualified from prize eligibility if they use another participant's bib, tamper with the timing chip, take shortcuts, receive unauthorised assistance, violate any Race Rule, engage in unsporting conduct or commit any Anti-Cheat violation. Any Anti-Cheat violation will result in immediate disqualification. The decision of Sports Timing Solutions shall be final and binding.

5. PRIZE DISTRIBUTION

Prize money will not be distributed on Race Day. All payments will be made via electronic bank transfer following successful verification and completion of all required documentation. Applicable taxes (TDS) shall be deducted at source in accordance with the laws and regulations of the Government of India.

6. SPECIAL AWARDS

A separate prize pool of ₹30,000 has been allocated towards Special Awards. Award categories and winners shall be determined solely by ACER RUN 2026.

7. PROTESTS & APPEALS

A runner can appeal to the Race Organizer in relation to the official race results declared, in writing, within 24 hours of the official announcement of the provisional results on Race Day. of the relevant race category. The decision of the Jury shall be final and binding on all.

8. GENERAL

- ACER RUN 2026 reserves the right to amend, modify, or interpret these Rules & Regulations at any time without prior notice.
- All decisions of Sports Timing Solutions relating to prize eligibility, verification, timing. documentation, and interpretation of these Rules & Regulations shall be final and binding.
- Participation in ACER RUN 2026 constitutes full acceptance of these Prize Money Rules & Regulations.

IMPORTANT INFORMATION

- Prize money will not be distributed on Race Day.
- All payments will be made via electronic bank transfer.
- All results are provisional until verified by Sports Timing Solutions (STS).
- Applicable TDS will be deducted as per Govt. of India regulations.
- Participation in the event constitutes acceptance of all rules.
